A LOOK AT THE COMMUNITY FOUNDATION FIELD

It's been more than 110 years since the first community foundation was created in Cleveland in 1914. Since then, the field has spread to the point that virtually every area of the United States is now served by a community foundation.

Since 2014, the Community Foundation Research and Training Institute has prepared a census of all US-based community foundations. The following report updates the information for data through 2023.

In preparing our list, we use the definition of a community foundation found in the National Standards. This definition reads:

A community foundation is a tax-exempt, nonprofit, autonomous, nonsectarian philanthropic institution supported by the public with the long-term goals of:

- Building permanent, component funds established by many separate donors to carry out their charitable interests
- Supporting the broad-based charitable interests and benefitting the residents of a defined geographic area, typically no larger than a state
- Serving in leadership roles on important community issues¹

So, using this definition, just how many community foundations are there in the United States? We *think* there are 900. This number can change over time, as new community foundations are created. But, given the maturity of the field, it is unlikely that this number will change much in the future.²

This report provides information on the aggregate value of assets in those community foundations. Also shown are asset growth rates during that time period.



HOW MUCH DID THE FIELD GROW?


According to this summary, total assets of US-based community foundations grew from \$84.4 billion in 2015 to \$158.1 billion in 2023. During this time period, the only aggregate decline in community foundation assets occurred in 2022, due to negative investment returns (more on this in the next section).



ASSET GROWTH AND INVESTMENT RETURNS

It is important to note that one of the most important factors in the change in assets at community foundations is the underlying investment returns. While community foundation assets are influenced by the level of gifts received and grants awarded, in most years the most important factor in the changes in asset levels is the performance of the assets in the foundation's portfolio.

Here is a chart showing changes in the asset levels at community foundations alongside the annual returns of the Morningstar 70/30 (70% stocks, 30% bonds) index:



WHO GREW THE MOST?

Larger Community Foundations

In 2016, there were 148 community foundations with assets in excess of \$100 million. Of those community foundations, here are the ones which had the fastest growth in the five years from 2018 to 2023.

As noted above, for community foundations with at least \$10 million in assets in 2018 the Greater Northwest Kansas Community Foundation had the highest percentage growth in the five years from 2018 to 2023.

A Note on the Data

We gathered this information from what was formerly known as The Columbus Survey (now completed by CF Insights), audited financial statements, and copies of a foundation's Form 990. Due to a lag in reporting, 2023 is the most recent year for which complete data is available.
