### Privacy Policy

Central Florida Foundation (“we” or “us”) respect and are committed to safeguarding the privacy of each host and guest who registers at <http://cffound.org/tabletalk>. This policy sets out how we will treat your personal information collected on this website.

#### What Information Do We Collect?

We may collect, store and use the following types of personal information:

- Information that you provide to us for the purpose of registering with us as a host or participant for Table Talk – including hosting information, information hosts provide for purposes of inviting guests, email addresses, cell phone numbers and home ZIP codes for purposes of geographic planning and reporting on events and participants. We may also collect information from your computer including but not limited to – geographic location, browser and operating system.
- Information that you provide us for the purpose of subscribing to our email notifications and/or newsletters.
- Any other information you choose to send to us.

#### Use of Cookies

Our website uses cookies. We use Google Analytics to analyze the use of this website. Google Analytics generates statistical and other information about website use by means of cookies, which are stored on users’ computers. The information generated relating to our website is used to create reports about the use of the website. Google will store this information. Google’s privacy policy is available [here](#).

Most browsers allow you to reject all cookies, while some browsers allow you to reject just third-party cookies. Blocking all cookies may, however, have a negative impact upon the usability of many websites, including this one.

#### Using Your Personal Information

Personal information submitted to us via this website will be used for the purposes specified in this privacy policy or in relevant parts of the website.

We may use your personal information to:

- Administer the website.
- Enable your use of the services available on the website - including registering as a host or participant, setting up an event page, inviting guests to a dinner, etc.
- Send you general communications regarding Table Talk.
- Email and text you a link to the Table Talk survey.
- Send you email notifications specific to your participation in Table Talk.
- Send you marketing communications relating to Central Florida Foundation and Table Talk which we think may be of interest to you by mail, or where you have specifically

agreed to this, by email or similar technology. You can inform us at any time if you no longer wish to receive our marketing communications.

- Compile and use statistical information about users as it relates to overall project response and results.
- Deal with inquiries made by or about you relating to the website.
- Keep the website secure and include safeguards to prevent fraud.
- Verify compliance with the terms and conditions governing the use of the website.

Where you submit personal information for publication on our website, we will publish and otherwise use that information in accordance with this privacy policy. We will not, without your express consent, provide your personal information to any third parties for the purpose of direct marketing.

### Disclosures

We may disclose your personal information to any of our employees, officers, agents, suppliers or subcontractors as reasonably necessary for the purposes set out in this privacy policy. We may disclose your personal information to fulfill the purpose for which you provide it (such as to allow you to invite guests to a dinner).

In addition, we may disclose your personal information:

- To the extent that we are required to do so by law.
- In connection with any ongoing or prospective legal proceedings.
- In order to establish, exercise or defend our legal rights (including providing information to others for the purposes of fraud prevention and reducing credit risk).
- If we believe disclosure is necessary or appropriate to protect the rights, property or safety of our organization, our customers, or others.

Except as provided in this privacy policy, we will not provide your information to third parties.

### Security of Your Personal Information

We take appropriate security measures (including physical, electronic and procedural measures) to help safeguard your personal information from unauthorized access and disclosure. We will store all the personal information you provide on our secure (password- and firewall-protected) servers.

However, no system can be completely secure. Therefore, although we take steps to secure your information, we do not promise, nor should you expect, that your personal information or other communications will always remain secure. Users should take care with how they handle and disclose their personal information and should avoid sending personal information through insecure e-mail. You are responsible for keeping your password and other login details for your individual host event page confidential. We will not ask you for your password (except when you log in to the website).

You may instruct us not to use your personal information for marketing purposes by sending an e-mail to us. In practice, you will usually either expressly agree in advance to our use of your personal information for marketing purposes, or we will provide you with an opportunity to opt out of the use of your personal information for marketing purposes.

Host registrant expressly agrees to release Central Florida Foundation and/or any of its agents and/or employees from any and all liability for any injury, theft or loss, and agrees to provide and pay for host's own insurance.
